Contribution of the answer to the COVID-19 response:
Substantively increases understanding of an issue
Provides a tangible solution to an issue
Provides a tangible solution to an issue
Provides feasible or actionable guidance or solution
Provides a full and complete answer to the Challenge Question
Clearly conveys findings to policy makers (e.g., plain language).
Demonstrates that the answer was arrived at via a rigorous analytic process.
